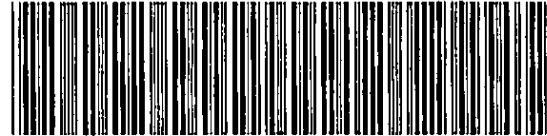



NAME & EFFECTIVE DATE
