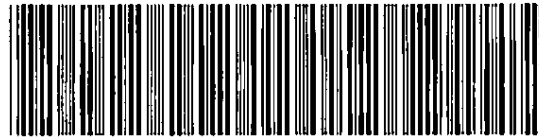

**ARTICLES OF ORGANIZATION

Name
