**ARTICLES OF ORGANIZATION
OF
WAYS DEHART HOLDINGS, LLC**

The undersigned person under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

WAYS DEHART HOLDINGS, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on October 10, 2017 with the Articles of Organization being filed with the Florida Department of State, and the existence of the company shall be perpetual.

The right of the members to admit additional members and the terms and conditions of the admissions shall be restricted solely to those members approved as set forth in the Company's Operating Agreement.


ARTICLE VII - MANAGEMENT BY MANAGER


ACCEPTANCE OF REGISTERED AGENT
