Articles of Organization

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Equilibrium Trading, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- 4. <u>Place of Business</u>. The mailing address of the Company's principal office is 15659 Laguna Hills Drive, Fort Myers, Florida 33908, and the street address of the Company's principal office is 15659 Laguna Hills Drive, Fort Myers, Florida 33908.
