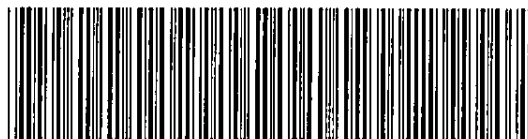

**RESTATEMENT OF ARTICLES OF ORGANIZATION

**ARTICLE I.
