ARTICLE I - Name:

The existence of the Company shall commence on the date these Articles of Organization are

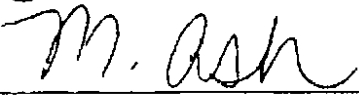

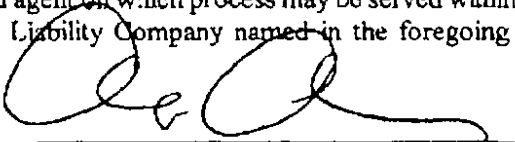
