OF

ARTICLE 1
Name

Restrictions on Transfer and Operating Agreement

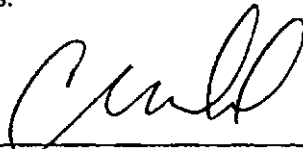
