4. Place of Principal Office. The mailing and street address of the Company's principal office is 3919 Sorrel Vine Drive, Wesley Chapel, Florida 33544.

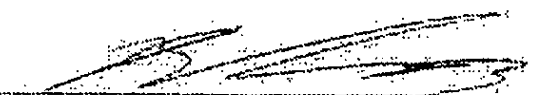

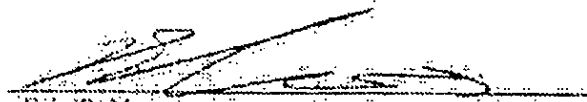
