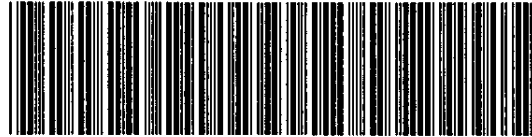

In order to protect the undersigned and the general public from the artifices of fraud and theft, it is in the best interest of all parties that this limited liability company be immediately dissolved.


