- FIRST:** The name and address of this Company is **GLOBAL CONSULTING SERVICES GROUP, LLC**, 759 Southwest 159th Terrace, Pembroke Pines, Florida 33027.
- SECOND:** The Articles of Organization were filed on January 1, 2018 and assigned document number L17000218165.
- THIRD:** The date of the adoption of these Articles of Dissolution is 29 March 2018.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
