

ATTACHMENT TO ARTICLES OF DISSOLUTION FOR A LIMITED LIABILITY COMPANY

Reasons:

1. Due to Florida's homeowners insurance crisis, being this is a home-based entity, we are unable to find reasonable premiums because of the business entity.
