ARTICLE 1: NAME AND EMBLEM

Section 1 (a)

a. Principle office of the Seminole Scouts Riding Club will be located in Panama City Beach, Florida. 312 Laureno Place. Panama City Beach FL. 32413.

b. Change of address: The designation of the principle office may change by amendment of these bylaws.

Section 1 (b)

IRC Section 501(c) (19) Purposes. Seminole Scouts Riding Club is organized exclusively for charitable, religious, educational and/or scientific purposes as specified in Section 501 (c) (19) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) (19) of the Internal Revenue Code. The Chapter Officers have the authority to change the bylaws if any part is found to be in conflict with Federal or Florida state tax laws.

Section 2

The emblem/logo used by the Seminole Scouts is the sole property of the Seminole Scouts. The Seminole Scout patch cannot be reproduced for sale or any other reason other than being presented to a new member. The emblem of the Seminole Scouts is in the shape of a skull with a Top Hat encompassed by the following colors. The incorporated colors are red; representing the blood that has been shed on the battlefield. The Military Gold; representing all branches of the military service of the United States. Black; representing the heavy hearts possessed for those who gave their lives and for those that are considered missing in action or prisoners of war. The skull and ace of spade represents the death that war leaves in its wake. The crossed sabers represent the Seminole Scouts as they were Cavalry of the United States Army.

ARTICLE 2: OBJECTIVES

General: Seminole Scouts Riders Club Protocol.

The Seminole Scouts are formed for the betterment of communication and camaraderie between Veteran's Organizations and or other groups that support Veterans and local charities.

Section 1

To promote interest in various forms of charitable work associated with veterans.

Section 2

To create and maintain camaraderie among Club members and promote and educate civilians about issues the military has with the Veterans Administration.

Section 3

To support Veterans Organizations.

Section 4

To raise awareness for veteran issues with the Veterans Administration.

Section 5

To conduct Club functions and activities in a manner befitting the members of the Seminole Scouts.

Section 6

To encourage a better understanding of a riders club as a constructive charitable organization to members of the public, press and law enforcement agencies.

ARTICLE 3: MEMBERSHIP

Definitions: The term "Good Standing" shall be defined as any person who has fulfilled the requirements for membership, who is not currently under disciplinary review or probationary status for disciplinary reasons, who has paid all necessary dues and conformed to the requirements as set forth in these bylaws. Any concerns of a member not in "Good Standing" will be reported by the Sargent AT Arms to the President.

Section 1

All members will be will be patched in during a regular meeting. Original members will vote for membership.

Full Member:

a. Will automatically be placed in the historical Seminole Scouts membership book.

ARTICLE 4: MEMBERSHIP DUES

Section 1

Chapter will not have dues unless voted by the chapter to maintain operating funds.

ARTICLE 5: ELECTIONS

Section 1

Chapter Officers will be set from the start- up of the chapter. These Officers will remain in their position. Elections will be held if an Officer steps down. The process to remove an Officer is as follows. If you are not happy with an Officer you must talk to them first. If difference cannot be cleared the person must stand during the betterment of the club portion of the meeting and state they request an election for that position. If you can't stand up in front of the club and voice your disagreement then you have none.

Section 2

All elected and or appointed officers to the Chapter Executive Board must remain active members in good standing for the duration of the term while in office. Any Officer missing three consecutive meetings without an excuse will automatically be removed from his or her position.

Section 3

All officers will be appointed from the original members. When an election is called for officers will assume office within 30 days of the election and hold that office until they choose to step down or requirements for an election are met.

Section 4

Should an elected officer resign from office for any reason a nomination and election may be held at any Regular Membership Meeting for a replacement to elected.

ARTICLE 6: DUTIES OF OFFICERS

Section 1

The Commander (CO) will have a vote in Executive Board meetings; preside over all meetings of the chapter; serve as Chairman of the Executive Board; issue the call for regular and special Chapter Executive Board meetings; schedule elections if needed and be sure they are held IAW the Bylaws.

Section 2

The Executive Officer (XO) will be a voting member of the Chapter Executive Board and perform all duties of the Commander in his absence; act as executive officer member of all committees; and assume all duties assigned by the CO.

Section 3

The Treasurer will be a voting member of the Executive Board and collect dues and other forms of income due to the chapter; maintain the accounting books; make payments from the chapter funds (when so ordered by the Chapter Executive Board); sign all chapter checks (along with another officer signature); and make regular reports of the chapter financial status to the chapter and assume all duties assigned by the CO.

Section 4

The Secretary will be a voting member of the Chapter Executive Board and shall keep the minutes of the Chapter Executive Board and general membership meetings; shall provide copies of the minutes to the general membership within 15 days of meeting; and assume all duties assigned by the CO.

Section 5

The Sergeant-At-Arms (SAA) will be a voting member of the Executive Board; maintain order during all meetings; insure that all in attendance are members in good standing or invited guest; be a liaison to any other association, club, or group and assume all duties assigned by the CO.

Section 6

In addition to the officers listed, the membership may nominate and elect the following non-voting officer positions: PRO, Chaplain and Quartermaster. These positions will be chapter Officers but will not be members of the Chapter Executive Board. These positions will assume all duties assigned by the CO and can be Full Members only.

a. The Public Relations Officer (PRO) will maintain a file and have it ready to present at each meeting and all chapter functions. He or She will be in charge of all Chapter publicity, in conjunction with and approved by the CO. Duties will include Historian, pictures, newspaper articles, TV and radio announcements and the Chapter website.

b. The Chaplain will keep the Chapter Executive Board informed of any member needs to include, but not limited to, hospitalization, accidents, and deaths. The Chaplain will also conduct Invocation and Benediction when asked.

c. The Quartermaster will ensure a conduit to procure goods and services for good of the Chapter. A full accounting record will be routed through the Chapter Treasurer.

ARTICLE 7: MEETINGS

Section 1

A quorum of conducting business shall be those present at any given meeting.

Section 2

Regular Membership Meetings will be held monthly at a date, time and place decided by the CO with input from the chapter. Any cancellation or change from monthly meetings must be posted through e-mails or text to the members. All members will show proper respect and conduct themselves in a manner that brings credit to the Chapter. Failure to comply will result in expulsion from the Regular Membership Meeting by the SAA.

ARTICLE 8: AMENDMENTS

Section 1

Amendments, when ratified by three fourths of the Full Members (in good standing) present at a Regular Membership Meeting, take effect immediately.

Article 9

Section 1

Vest of members who ride a motorcycle will be worn to every meeting. The vest will only have the club patch on the back with exception of military members can wear combat patches earned on the upper right side of the rear of the vest. Non-combat patch (only one so pick your best) will be worn on the upper left side of the vest. No other patch, insignia or anything else is authorized to be worn on the back of the vest. Support patches will not be worn anywhere on the vest. We are neutral and will not show support for any club. We will support any club in poker runs ect. to help that club raise money for their charity.

Section 2

Soft colors will be worn by members who do not ride a motorcycle. Historically vest are worn by members of motorcycle clubs or motorcycle riding clubs or associations. This section can be changed after formation as any by-law can be changed as written in Article 8.
