The undersigned, Gary Johns, a natural person competent to contract and an authorized representative of TallyTimber, LLC, hereby presents these Articles of Organization as the Articles of Organization of TallyTimber, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TallyTimber, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal address of the Company is 17 SE Eglin Parkway, Fort Walton Beach, Florida 32548. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE VI - MANAGEMENT


