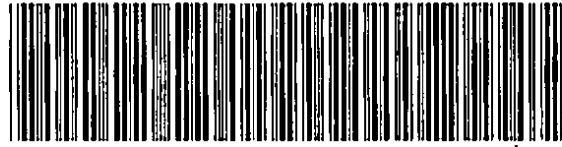

The undersigned, Marisol C. Taborda, natural person, older than twenty-one years of age, whom is citizen of the United States, is acting as the organizer of the Limited Liability Company, *Sea & Sun Cleaning Service LLC*, by this articles being formed under (Chapter 605, Florida Statutes (F.S.) hereinafter called the Act, and do hereby certify as follows:

Article I. Name: The name of this Company is *Sea & Sun Cleaning Service LLC*.

Article II. Principle Office: The principal office of the Company shall be located is the City of Winter Garden, 16137 Wind View Lane, Orange County, Florida. The Company shall have full power and authority to change the principle office from one location to another.

Article III. Purpose: The purpose of this Company is to engage in any lawful act or activity for which limited liability may be organized under the Act, offering professional cleaning service for residential homes and commercial institutions for profit.

Article IV. Duration: Perpetual Duration.

Article V. Agent for service of Process: *Marisol C. Taborda*, who resides at *16137 Wind View Lane, Winter Garden, Florida 34787*, is hereby designated as the agent of the Company upon whom process against the Company may be served.

Article VII. Management: This Company is to be managed by the Members.


Article VIII. Liability of Members: All Members who shall be liable for the Company, in their capacity as members of the Company, shall be liable for all debts, obligations and liabilities of the Company pursuant to Section (e.g. 303 of the Uniform Limited Liability) of the Act.

Article XI. Liability of Managers: A member acting in his, her or its capacity as a Manager of the Company shall not be personally liable to the Company or to its members for damages for any breach of duty in such capacity as a Manager, except for damages resulting from actions or omissions by such Manager, as to which there shall have been a judgement or other final adjudication that establishes that such acts or omission were in bad faith, involved intentional misconduct or a knowing violation of law, or that such manager personally gained a financial profit or other advantage to which he, she or it was not legally entitled. Neither the amendment nor the repeal of this Article shall eliminate or reduce the effect of this Article in respect of any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision. This Article shall neither eliminate nor limit the liability of a Manager for any act or omission occurring prior to the adoption of this Article.

Article X. Classes of Members: The Company may, from time to time, establish classes, or series of classes, of members with such relative rights, designation, qualifications, preferences and duties as may be adopted as set forth in the Company's Operating Agreement.

Article XI. Operating Agreement: These Articles shall be deemed to be the Operating Agreement of the Company, unless and until the Members shall have otherwise adopted additional or inconsistent provisions in connection with any matters permitted to be addressed in an Operating Agreement.

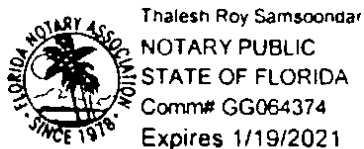




