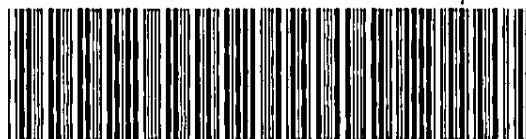

Dear Sir/Madam:

I made an inquiry as to the enclosed letter rejecting "Service Excellence Corps, LLC" as the name for a new Florida entity.

I was informed that the name was rejected because the word "Corps" may cause confusion as to the type of entity being formed; that is, the limited liability company may be mistaken as a corporation.

However, I was further informed that we may choose to submit an affidavit together with the Articles of Organization explaining that we do understand the potential for confusion by using the word "Corps", yet opt to use the word anyway.

While choosing a new name may be the most straightforward option, in order to remain consistent with the conversion documents filed in Colorado, we have chosen to remain with the name, "Service Excellence Corps, LLC", as the name for the new Florida entity.

I have enclosed:

1. Copies of the rejection letter, Articles of Conversion dated October 4, 2017, and Articles of Organization dated October 4, 2017;
2. An affidavit regarding the use of the word "Corps" in the new entity's name.

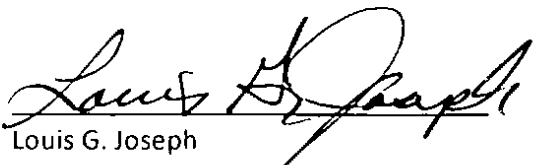

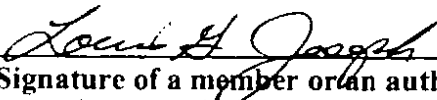
