The name of the limited liability company is: PETERSEN LEASING, LLC

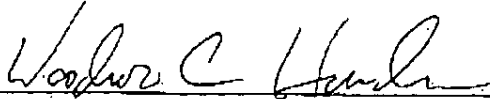
ARTICLE II. ADDRESS
