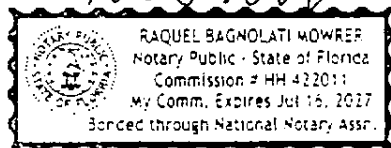
As soon as I found out about the situation today, my accountant took the necessary measures and reversed the changes on SunBiz and advised me to go to the police and was told to file the report attached.
