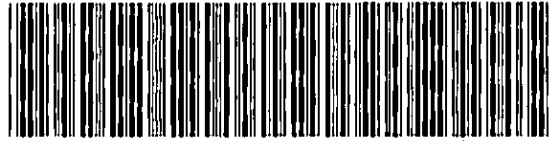

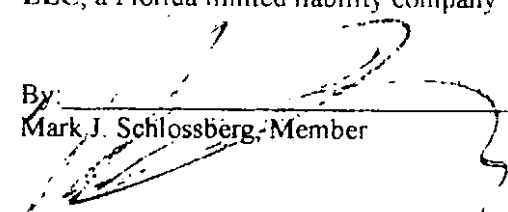

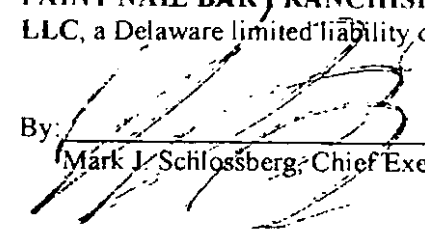
1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is Paint Nail Bar Franchise Company, LLC.

The mailing address and street address of the principal office of the Company is 1417 First Street, Suite 1010, Sarasota, Florida 34236.

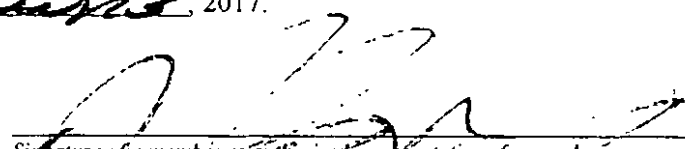

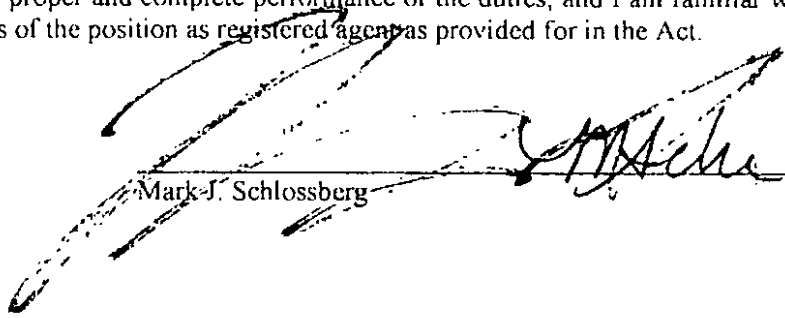
