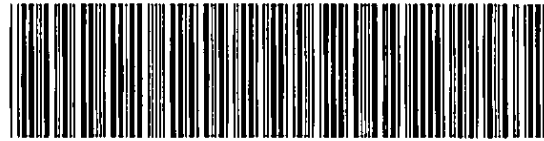

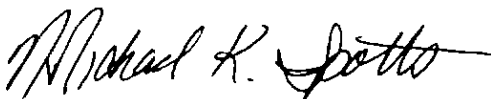
We are in receipt of your letter dated November 15, 2017 regarding the articles amendment this firm filed on behalf of our client and his corporation. Due to a scrivener's error on our part the LLC was originally formed under the wrong name. It was formed as Czar of Cars LLC it should have been formed as Czar of Realty LLC.

When we learned of our error we mailed the request for amendment of articles or organization asking the the LLC name be changed to Czar of Realty LLC and included check #1723 for 25.00 with the application to make the change.

The November 15, 2017 letter received by our office indicated that the LLC could not be called Czar of Realty LLC due to a corporation called Czar of Realty Incorporated causing a "name conflict". 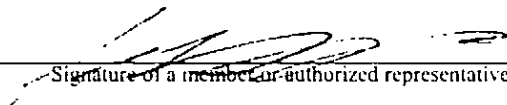
