**ARTICLES OF ORGANIZATION
OF A
FLORIDA PROFESSIONAL
LIMITED LIABILITY COMPANY**

The undersigned, in forming a Florida Professional Limited Liability Company ("Company") under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and any other laws of the State of Florida, hereby adopt the following Articles of Organization for such Company:

ARTICLE I - NAME

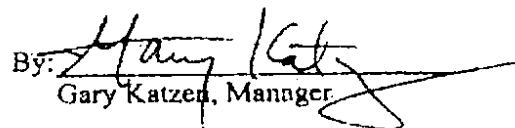
The duration of the Company is perpetual.
