AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF SSL SJ MANAGEMENT LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of SSL SJ Management LLC, originally filed on November 3, 2017, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is SSL SJ Management LLC (the "Company").

ARTICLE II - ADDRESS

The street and mailing address of the Company's principal office are:

ARTICLE III - PURPOSE

The Company is organized for the purpose of performing all lawful business permitted under the laws of the United States and of the State of Florida.
