AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

**ANDREW JUN, LLC
(the "LLC")**

The LLC was originally formed as Jun Law Group, LLC, by the Articles of the Organization dated November 7, 2017 (the "Original Articles"). These Amended and Restated Articles of Organization amend and restate the Original Articles.

ARTICLE I: NAME

The name of the limited liability company is Andrew Jun, LLC.

ARTICLE II: ADDRESS

The street and mailing address of the initial principal office of the LLC is:

ARTICLE III: REGISTERED AGENT

ARTICLE IV: EFFECTIVE DATE AND TIME

The effective date and time of these Amended and Restated Articles of Organization shall be the date and time that these Amended and Restated Articles of Organization are filed with the Florida Department of State, Division of Corporations.

ARTICLE V: PURPOSE

The LLC is being formed for the purpose of transacting any and all lawful business for which a limited liability company may be organized in the State of Florida.

ARTICLE VI: DURATION

The LLC shall have an indefinite duration.

ARTICLE VII: MANAGEMENT

ARTICLE VIII: TRANSFERABILITY OF MEMBERSHIP INTERESTS

No member shall have the right to assign their membership interests in the LLC without the written agreement of all of the membership interests, unless otherwise provided in the LLC's Operating Agreement. If the assignment is not approved by all of the membership interests, the assignee shall have no right to become a member, to participate in the management of the LLC, or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

ARTICLE IX: DISTRIBUTION OF PROFITS

Unless otherwise provided in the LLC's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the LLC. The voting members shall have complete discretion on when and if to approve any distribution of profits.
