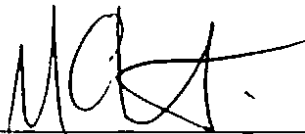

FOR

a Florida Professional Limited Liability Company

The undersigned, an authorized representative of a Member, desiring to form a professional limited liability company under and pursuant to Florida Statute 605, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I - NAME
