## ARTICLES OF ORGANIZATION OF ST. PETE OB/GYN, LLC

The undersigned, under the provisions of Chapter 605 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do(es) hereby provide and set forth the following:

#### Articles

- 1. Name. The name of the limited liability company is <u>St. Pete OB/GYN, LLC</u> (hereinafter referred to as the "Company").
- 2. <u>Commencement Date; Duration</u>. The effective date of the commencement of this Company shall be on the date these articles are filed by the Florida Department of State. Unless earlier terminated under the Act or pursuant to the Operating Agreement, the period of duration of the Company shall be perpetual.
- 3. <u>Purpose</u>. The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.
- 4. <u>Mailing Address and Principal Office</u>. The initial mailing address for the Company is <u>603 7th St. S., Suite 300, St. Petersburg, FL 33701</u>, and the street address of the principal office of the Company is <u>603 7th St. S., Suite 300, St. Petersburg, FL 33701</u>. These addresses may be changed from time to time as provided in the Operating Agreement.
- 5. <u>Registered Agent.</u> The initial registered agent in Florida for the Company is <u>Nita Davis</u>, and the initial registered office is located at <u>603 7th St. S., Suite 300, St. Petersburg</u>, FL 33701.
- 6. Members. The Company shall initially have three (3) Members, but shall always have at least one (1) Member. The Company may admit additional Members as provided in these Articles of Organization and the Operating Agreement adopted by the Members. All Members shall be subject to the terms and provisions of these Articles of Organization and the Operating Agreement adopted by this Company. The names and addresses of the initial Member(s) of the Company are as follows:

- 6. <u>Capital Contributions</u>. Contributions to the capital of the Company shall be made by the members to the extent and in the manner prescribed by the written Operating Agreement made and entered into by the members, which Operating Agreement may be amended from time to time in accordance with its terms.
- 8. Management Member Managed. This shall be a member-managed Company, and the management and control of the business and affairs of the Company shall be vested in its members according to the Act, these Articles of Organization, and the Operating Agreement adopted by the members (as amended from time to time). Except as may be otherwise specifically set forth in the Operating Agreement, no other person or entity (other than a member) shall have any right or authority to participate in the management of the Company.

The Operating Agreement for the Company may contain any provision(s) allowed by the Act or law, including without limitation any provisions for the operation, regulation, management and conduct of the business and affairs of the Company which are not deemed invalid and/or prohibited by law, and which are not in conflict with these Articles of Organization. In the event of any conflict between the terms and provisions of the Act and these Articles of Organization, these Articles of Organization shall govern and control except to the extent such term or provision is prohibited, or deemed invalid, by the Act. In the event of any conflict between the terms and provisions of the Operating Agreement and these Articles of Organization, these Articles of Organization shall govern and control. In the event of any conflict between the terms and provisions of the Operating Agreement and the Act, the terms and provisions of the Operating Agreement shall govern and control except to the extent prohibited, or deemed invalid, by the Act.

Notwithstanding the foregoing, nothing herein shall be construed to prohibit or restrict the delegation of a member's power and/or authority to manage and/or control the business and/or affairs of Company as provided in the Act and/or the Operating Agreement, or in any separate writing such as a management agreement.

7. <u>Amendments to These Articles of Organization</u>. These Articles of Organization may only be amended or modified with the vote, or written consent without a meeting, of all of the Members.
