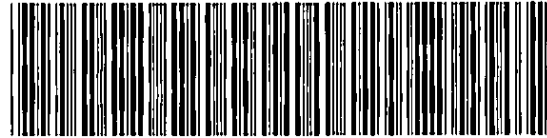

The name of the Company shall be Verel & Associates, LLC.


ARTICLE II.


