

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF THE OASIS AT MOSS PARK PRESERVE, LLC

The undersigned hereby submits these Articles of Organization (these "A/R Articles of Organization") for The Oasis at Moss Park Preserve, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE I - Name ·

The name of the limited liability company is The Oasis at Moss Park Preserve, LLC (the "Company").

ARTICLE II - Address

The mailing and street address of the principal office of the Company is 247 North Westmonte Drive, Altamonte Springs, Florida 32714.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of a written operating agreement of the Company, as the same may be amended from time to time (the "Operating Agreement").

ARTICLE IV - Management and Officers

The Company shall be manager-managed, elected as described in the Operating Agreement. The manager of the Company (the "Manager") shall be DRPRMP Manager, LLC, 247 North Westmonte Drive, Altamonte Springs, Florida 32714.

The Company may also have such officers as may be appointed in those A/R Articles of Organization or a may be otherwise appointed by the Manager pursuant to the terms of the Operating Agreement. The initial officers of the Company are as follows:

Robort M. Picerne - President Richard R. Halay - Executive Vine President Edward L. Wernecke - Executive Vice President

Unless a Statement of Denial has been filed by the Company, officers of the Company shall be authorized to legally bind the Company and such authority shall be in addition to the signatory authority granted to the officers and to the Manager under the Operating Agreement or otherwise by operation of law, and the signature of either the Manager or any designated officer shall be sufficient to bind the Company.

ARTICLE V - Admission of Additional Members

The Company shall admit new members only upon the unanimous written consent of all the then-existing member(s) of the Company or as otherwise provided in the Operating Agreement.

The Company reserves the right to amend any provision of these A/R Articles of Organization, which amendment shall only be effectuated by a writing executed by the Manager of the Company.
