**ARTICLES OF ORGANIZATION


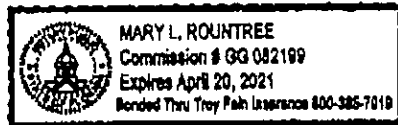
