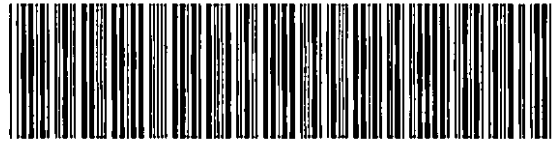

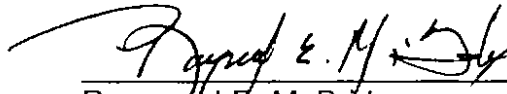
## ARTICLE V - MANAGEMENT

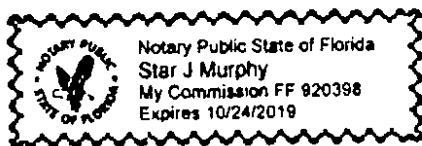

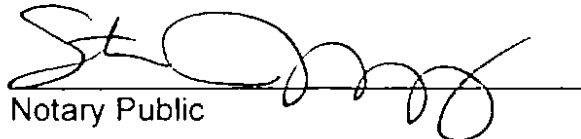

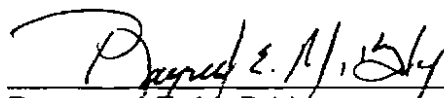
