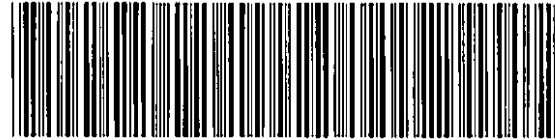

Any member shall have authority to bind the company.


ARTICLE VI - MANAGEMENT


