ARTICLES OF DISSOLUTION OF

- SECOND:** The Articles of Organization were filed on November 20, 2017 and assigned document number L17000238719.
- THIRD:** The date of the adoption of these Articles of Dissolution is 26 March 2018.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0708.
