**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF ORGANIZATION  
OF  
4 PILLAR HOLDINGS, LLC**

**4 PILLAR HOLDINGS, LLC**, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization as now in effect (the "Articles of Organization"), in accordance with the requirements of Section 605.0202, Florida Statutes, does hereby certify as follows:

1. The name of the Company is 4 Pillar Holdings, LLC, and its Document Number with the Florida Department of State is L17000238860.

2. The Articles of Organization were filed with the Florida Department of State on November 20, 2017.

3. The Amendment to the Company's Articles of Organization being effected hereby is made in order to change the Company from a manager-managed limited liability company to a member-managed limited liability company pursuant to Section 605.0102(41) and Section 605.0407 of the Florida Revised Limited Liability Company Act and to reflect the initial members of the Company in the Florida Department of State's records.

4. The Amendment to the Company's Articles of Organization being effected hereby was duly authorized and adopted by the Members of the Company by written consent on January 8, 2018.

5. These Articles of Amendment to the Company's Articles of Organization shall be effective immediately upon filing hereof with the Florida Department of State.

6. The Articles of Organization are hereby amended by deleting Article IV in its entirety and replacing it as follows:

**"ARTICLE IV**

**Member Managed**

The Company shall be a member-managed limited liability company pursuant to the provisions of Section 605.0102(41) and Section 605.0407 of the Florida Revised Limited Liability Company Act. The names and street addresses of the initial members of the Company shall be:

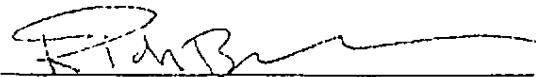
