ARTICLES OF ORGANIZATION OF JMK CONSULTANTS LLC

The undersigned certifies that the members described herein have associated themselves for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
