**SECOND AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF

The undersigned authorized representative of **WWSG Travel, LLC**, a limited liability company organized and existing under the laws of the State of Florida (the "**Company**"), whose Articles of Organization were originally filed with the Florida Department of State on November 21, 2017, Document Number L17000240458, and as previously amended and restated on February 26, 2019, hereby adopts the following Second Amended and Restated Articles of Organization of the Company:

**ARTICLE I**  
**Name**

The name of this limited liability company (the "**Company**") shall be:


**ARTICLE VI**


