An Operating Agreement, the power to adopt, alter, amend or repeal which shall be vested in the Members of the Company, and shall govern the management, operation and ownership of the Company.

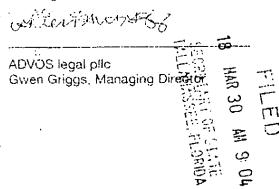
#### ARTICLE VIII: LIMITED LIABILITY
