Operating Agreement

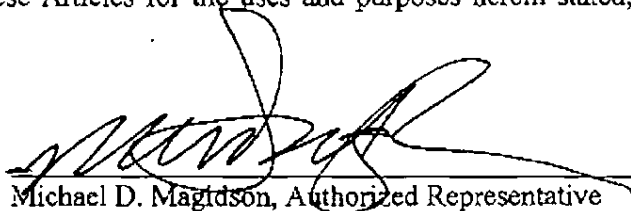
