Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company (the "Act"), 10551 Lippizan Road LLC, a Florida limited liability company, formed on November 27, 2017 with document number L17000242843 (the "Merging Entity") and 13851 Treeline Avenue LLC, a Florida limited liability company, formed on November 27, 2017 with file number L17000242829 (the "Surviving Entity"), adopt the following Articles of Merger merging the Merging Entity with and into the Surviving Entity (the "Merger"):

SEVENTH: This Certificate may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
