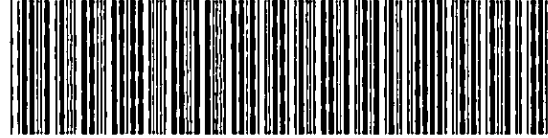

The name of the Limited Liability Company is BANKING BUSINESS NETWORK, LLC.






