ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
USWF RADIATION REAL ESTATE, LLC

The undersigned, being an authorized member of USWF Radiation Real Estate, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is USWF Radiation Real Estate, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective November 30, 2017, and the Florida document number assigned to this Company is L17000245972.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:
