ARTICLES OF ORGANIZATION  
OF WALKER REAL ESTATE LEASING, LLC

The undersigned authorized representative of a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization:

ARTICLE I. NAME: The name of the company shall be Walker Real Estate Leasing, LLC.
