The initial members of the Company shall be Poonam Warman and Getta Parvati Minocha.



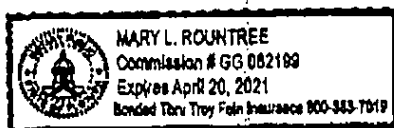


