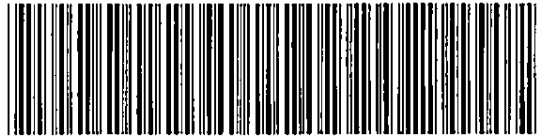



The Company will be manager- managed. The name and address of the sole manager is:


