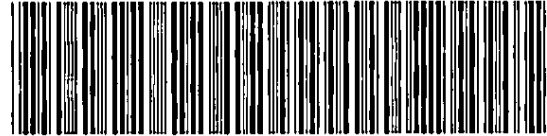

ARTICLES OF ORGANIZATION

OF

WHATCHAMATECH, LLC

AGREEMENT made as of the 30 day of November, 2017, by **MICHAEL WAYNE CREWS, JR.**, (hereinafter the Member);

NOW THEREFORE, it is mutually agreed as follows:

ARTICLE I

FORMATION OF LIMITED LIABILITY COMPANY

The Member hereby creates a limited liability company (the "LLC") under Chapter 605, Florida Statutes, the laws of the State of Florida (the "Act") for the purposes described in Article III below.

ARTICLE II

NAME

ARTICLE III
PURPOSES AND POWERS

The LLC is organized for the purpose of web development and computer programing related to web development, in addition to server administration and any other legal and lawful purposed for which a limited liability company may be organized pursuant to the Act. The LLC shall have all the powers granted to a limited liability company under the laws of the State of Florida.

Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the LLC to carry on any business, exercise any power, or do any act which a limited liability company may not, under the laws of the State of Florida, lawfully carry on, exercise, or do.

ARTICLE IV
PRINCIPAL PLACE OF BUSINESS

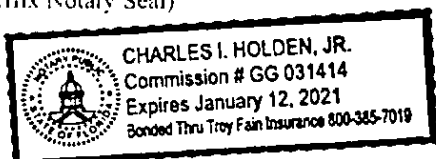
