#### ARTICLES OF ORGANIZATION

OF

#### WHATCHAMATECH, LLC

AGREEMENT made as of the <u>30</u> day of <u>November</u>, 2017, by MICHAEL WAYNE CREWS, JR., (hereinafter the Member);

NOW THEREFORE, it is mutually agreed as follows:

#### ARTICLE I

#### FORMATION OF LIMITED LIABILITY COMPANY

The Member hereby creates a limited liability company (the "LLC") under Chapter 605.

Florida Statutes, the laws of the State of Florida (the "Act") for the purposes described in Article III below.

ARTICLE II

NAME
