**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the Members, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of 1105 HILLSBORO LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on December 4, 2017, and assigned document number L17000247687, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

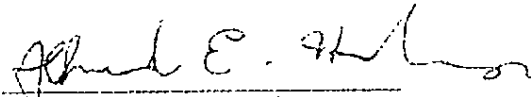
ARTICLE VI. PURPOSE

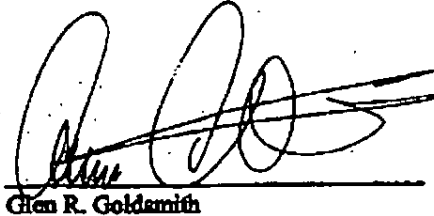
