ARTICLES OF ORGANIZATION K & N BOATS, LLC

ARTICLE IV RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. Each of the Members shall enter into an Operating Agreement for the Company containing such terms and conditions as are agreed upon by the Members.
