Registered Agent and Office

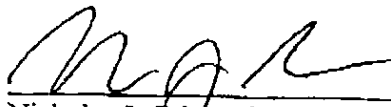

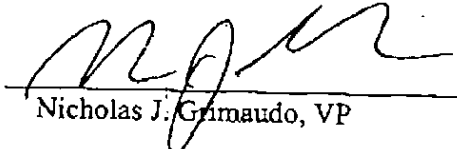
