

KNOW ALL MEN BY THESE PRESENTS: That we, Lisa M Figueroa desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. Company Name: That the name of the limited liability company is Figueroa Holding Company, Limited Liability Company.
- 2. Duration: That the period of duration of this limited liability company is thirty years from the date of filing hereof with the Florida, unless sooner dissolved as provided by Florida law.
- 3. Purpose: That the purpose for which this limited liability company is organized is primarily to any and all legal business, and other goods and services that are permitted by law, within and without the Florida as the laws of Florida and other states permit.
- 4. Principal Place of Business: That the address of its principal place of business is 100 South Semoran Blvd Orlando, FL 32807


