**ARTICLES OF ORGANIZATION

**ARTICLE I – Name**

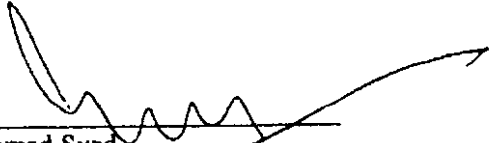

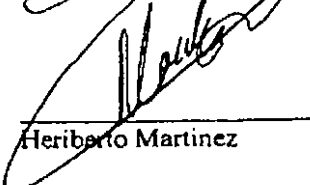
