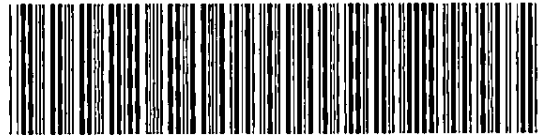



These Articles of Amendment to the Articles of Organization of the Company ("Amendment") is submitted to amend the Articles, as amended, as follows:


