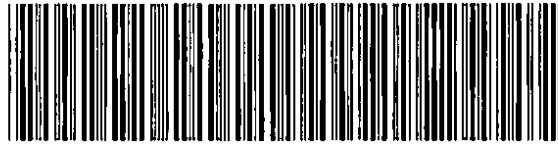

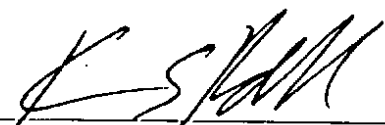

The name of the limited liability company is Trendsight Oral Care, LLC (hereinafter referred to as the "Company").

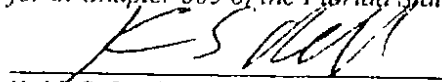

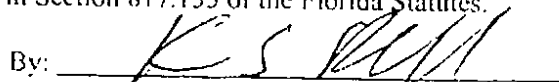
